### Terms of Adoption

1. The adopter agrees to provide this animal with a safe, loving, indoor home; proper food, water, exercise, shelter, identification, and humane care.
2. The adopter agrees to provide routine and emergency veterinary care, including vaccines, parasite prevention, and any recommended treatment.
3. This animal may not be sold, given away, transferred, abandoned, used for breeding, or surrendered to a shelter. If the adopter can no longer keep the animal, Hope for Dogs & Cats PR must be contacted first.
4. The adopter understands that rescue animals may need time to decompress and may have unknown history, medical needs, or behavior needs. The adopter accepts responsibility for safe introductions, training, supervision, and ongoing care.
5. The adopter agrees to keep dogs leashed or securely contained and cats safely indoors unless otherwise approved in writing. The animal will not be allowed to roam.
6. If not already spayed/neutered because of age or medical status, the adopter agrees to complete spay/neuter by the date recommended by Hope for Dogs & Cats PR or the veterinarian and provide proof when requested.
7. The adopter confirms that all household members agree to this adoption and that pets allowed by any landlord, HOA, or housing rules are permitted.
8. Hope for Dogs & Cats PR may request updates and may reclaim the animal if this agreement is violated or the animal is found to be neglected, abused, abandoned, or kept in unsafe conditions.
9. The adoption fee is a donation toward rescue expenses and is generally non-refundable once adoption is complete, except where otherwise required by law or agreed in writing.
10. To the fullest extent permitted by law, the adopter releases and holds harmless Hope for Dogs & Cats PR, Inc., its directors, volunteers, fosters, and transporters from claims arising after adoption, including illness, injury, damage, bites, escape, or behavior issues.
11. This agreement is the full adoption understanding between the parties. Any changes must be in writing. Venue and governing law will be the applicable law of the state where the adoption is completed.
